Daniel Martz

Major Daniel Morris Martz, Jr died from wounds received from small arms fire 12 February 1966 while serving with SD-5891, HQ, MACV, RVN. He had been in country 234 Days.



Thomas Dobrinska

Second Lieutenant Thomas Earl Dobrinska died from multiple fragmentation wounds 10 February 1968 while serving with B Co, 2nd Battalion, 12th Cavalry, 1st Cavalry Division, RVN. For action on this date he was posthumously awarded the Distinguished Service Cross. He is also the recipient of two Silver Stars. He had been in country 167 Days.



Michael Enbody

First Lieutenant Michael William Enbody died from gun or small arms fire 12 February 1968 while serving with CRIP Plt, HHC, 2nd Bn, 27th Infantry, 25th Infantry Division, RVN. He had been in country 63 Days.



Richard Bruce

First Lieutenant Richard Philip Bruce died from wounds received 12 February 1968 while serving with D Co, 5th Bn, 7th Cavalry, 1st Cavalry Division, RVN. He had been in country 117 Days.



Robert Prine

First Lieutenant Robert Wayne Prine died from a non hostile weather related helicopter crash 12 February 1968 while serving as a pilot with B Trp, 1st Sqdn, 9th Cavalry, 1st Cavalry Division, RVN. He had been in country 19 Days.



Jeffery Hults

First Lieutenant Jeffrey Andrew Hults died from artillery, rocket or mortar fire 12 February 1968 while serving with A Co, 2nd Bn, 34th Armor, 25th Infantry Division, RVN. He had been in country 184 Days.



Verne Kelley

First Lieutenant Verne Carl Kelley died from gun or small arms fire 12 February 1969 while serving with Det B-20 (2nd MSFC), B Co, 5th Special Forces Group, RVN. He had been in country 176 Days.



Wesley Hendrickson

First Lieutenant Wesley Paul Hendrickson died from gun or small arms fire 12 February 1969 while serving with B Co, 1st Bn, 27th Infantry, 25th Infantry Division, RVN. He had been in country 44 Days.



William Scott

First Lieutenant William Gravelle Scott, Jr died while passenger on military aircraft 12 February 1969 while serving with ADV Team 31, HQ, MACV Advisors, RVN. He had been in country 225 Days.



John Gibbons

Captain John Michael Gibbons died from hostile fire 12 February 1970 while serving as a pilot with 174th AHC, 14th Avn Bn, 16th Avn Group, Americal Division, RVN. He had been in country 197 Days.



Billy Smith

Captain Billy Jake Smith died from an other explosive device 12 February 1970 while serving with Adv Team 98, HQ, MACV Advisors, RVN. He had been in country 271 Days



Gary Larson

First Lieutenant Gary Wayne Larson died from wounds from gun or small arms fire 12 February 1971 while serving with 1st Plt, C Co, 1st Bn, 11th Infantry, 5th Infantry Division, RVN. Actual date of incident was 25 Dec 1970. He had been in country 105 Days.

Harold Lowery

◆ DISTINGUISHED SERVICE CROSS ◆

Major Leonard Lowery was awarded the Distinguished Service Cross for actions on 12 February 1951 while serving as Commanding Officer Company C, 1st Battalion, 38th Infantry Regiment, 2nd Infantry Division, Korea. He is also the recipient of two Silver Stars and Bronze Star with V. He was inducted into the OCS Hall of Fame in 1959.



James Magouyrk

◆ DISTINGUISHED SERVICE CROSS ◆

First Lieutenant James R. Magouyrk IN 5-68 was awarded the Distinguished Service Cross for actions on 12 February 1969 while serving with Company C, 3rd Battalion, 506th Infantry, 101st Airborne Division, RVN. He was inducted into the OCS Hall of Fame in 2024.
