**Thomas Cooney**

Second Lieutenant Thomas Joseph Cooney IN 32-67 died from multiple fragmentation wounds 25 February 1968 while serving with A Co, 2nd Bn, 3rd Infantry, 199th Infantry Brigade, RVN. He had been in country 17 Days.



**Gordon Hughes**

Second Lieutenant Gordon Kay Hughes, Jr IN 27-67 died from gun or small arms fire 25 February 1968 while serving with C Co, 5th Bn, 60th Infantry, 9th Infantry Division, RVN. He had been in country 51 Days.



**George Parounagian**

Second Lieutenant George Parounagian, Jr IN 34-67 died from gun or small arms fire 25 February 1968 while serving with 2nd Plt, C Co, 2nd Bn, 27th Infantry, 25th Infantry Division, RVN. He had been in country 100 Days.



### **Anton Bloemhard**

First Lieutenant Anton Leonard Bloemhard IN 10-65 died from gun or small arms fire 24 February 1967 while serving with C Co, 1st Bn, 35th Infantry, 4th Infantry Division, RVN. He had been in country 155 Days.



### **Franklin Bryan**

Captain Franklin Delano Bryan IN 16-66 died from hostile fire causing a helicopter crash 25 February 1968 while serving as a pilot with D Trp, 3rd Sqdn, 5th Cavalry, 9th Infantry Division, RVN. He had been in country 449 Days.



### **Richard Brunn**

First Lieutenant Richard Conrad Brunn IN 37-67 died from an other explosive device 25 February 1969 while serving with ADV Team 60, HQ, MACV Advisors, RVN. He had been in country 245 Days.



### **Phil Johnson**

First Lieutenant Phil David Johnson IN 64-67 died from an other explosive device 25 February 1969 while serving with C Co, 1st Bn, 502nd Infantry, 101st Airborne Division, RVN. He had been in country 112 Days.



### **Alan Johnson**

First Lieutenant Alan Paul Johnson IN 4-69 died from gun or small arms fire 25 February 1970 from wounds received on 17 Feb 1970 while serving with 2nd PLT, B Co, 3rd Bn, 506th Infantry, 101st Airborne Division, RVN. He had been in country 82 Days.



### **Michael Maloney**

Captain Michael Kevin Maloney IN 520-68 died from an other explosive device 25 February 1971 while serving with ADV Team 88, HQ, MACV Advisors, MACV, RVN. He had been in country 121 Days.



### **Mark Fitzgerald**

First Lieutenant Mark Joseph Fitzgerald IN 20-70 died from a non hostile aircraft crash 25 February 1972 while serving with C Trp, 7th Sqdn, 17th Cavalry, 1st Aviation Bde, RVN. He had been in country 134 Days.
