First Lieutenant Wilofard A McClain II FA 16-67 died from an other explosive device 28 March 1968 while serving with C Co, 101st Avn Bn, 160th Avn Group, 101st Airborne Division, RVN. He had been in country 200 Days.

First Lieutenant Earl Frederick Browne IN 64-67 died from gun or small arms fire 28 March 1969 while serving with ADV Team 47, HQ, MACV Advisors, RVN. He had been in country 140 Days.



Eric Pulliam

First Lieutenant Eric Vincent Pulliam FA 30A-67 died from an air loss 28 March 1969 while serving with C Co, 101st Avn Bn, 160th Avn Group, 101st Airborne Division, RVN. He had been in country 34 Days.



Marvin Roberts

Captain Marvin James Roberts IN RC2-64 died from multiple fragmentation wounds 28 March 1969 while serving with B Co, 1st Bn, 11th Infantry, 5th Infantry Division, RVN. He had been in country 269 Days.



Terry Graham

First Lieutenant Terry Durand Graham FA 33A-67 died from gun or small arms fire 28 March 1969 while serving with 2nd CA PLT, ADV Team 47, HQ, MACV Advisors, RVN. For action on this date he was posthumously awarded the Silver Star. He had been in country 248 Days.



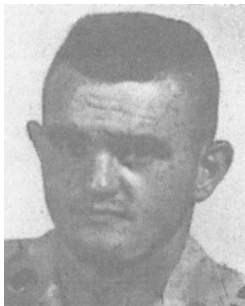
Kenneth Hughes

Captain Richard V Jr Knight IN 50-67 died from artillery, rocket, or mortar fire 28 March 1971 while serving with C Co, 1st Bn, 46th Infantry, Americal Division, RVN. He had been in country 181 Days.

First Lieutenant Joseph R Ryan, Jr IN 28-71 died from an other explosive device 28 March 1971 while serving with Mobile ADV Team 68. ADV Tea, 41. HQ, MACV Advisors, RVN. He had been in country 320 Days.
